



ABSTRACT

The importance for child budgeting has been emphasised that there must be compulsory allocations for child budget and such allocations must be reported in statement 12 (Allocation for children). The Government has not only acknowledged the need for provisioning suitable resources for children, it is also committed to secure and protect their interest while defining the schemes and programme for future growth of India. Nutrition interventions are spread across sectors such as food security, health, education, water and sanitation, poverty alleviation, social safety and agriculture. The past few years have seen some major transformations in terms of the nation's progress vis-à-vis child nutrition and development. Children need a safe, protecting and enabling environment in which they can learn, grow and develop to their full potential. Therefore, child budget on health and nutrition sectors needs to be discussed to reach out of children.
