#### ABSTRACT

For a long time, Rohingyas have been the most persecuted minority in Myanmar. Recently, the Rohingya issue attracted the attention of nations and international organizations when millions of Rohingya were forced to leave Myanmar and take shelter in other nations. They took refuge in various countries like Malaysia, Thailand, Bangladesh, and India etc; about 40 thousand Rohingya people are staying in India with the status of refugees.
