Golding, who was a philosophy teacher before becoming a Royal Navy lieutenant, experienced war firsthand, and commanded a landing craft in the Normandy landings during D-Day in 1944. After the war ended and Golding returned to England, the world was dominated by the Cold War and the threat of nuclear annihilation, which led Golding to examine the nature of humanity and went on to inspire Lord of the Flies.
